Neither Form 9D nor 9E is required on a routine vendor take back mortgage as this type of transaction is exempted by section 24(2)(f) of By-Law 9: "the lender is selling real property to the borrower and the charge represents part of the purchase price". Because of the nature of the transaction, the lender/vendor can be expected to be aware of the security and is frequently intimately involved.
